The exchange charges 2% of the value of the water transfer plus GST as a brokerage fee, with a maximum fee of \$500.00 in a water season applying to CIT customers.

Other Requirements and Fees

Depending on the actual circumstances of your successful trade you may be required to complete additional water authority application forms (CIT and/or Water Department) and pay water authority application fees.

Terms and Conditions

1. I consent to water traded under the terms of this Agreement to be adjusted by Central Irrigation Trust against the CIT Account Number listed in the Schedule.
2. CIT Water Exchange will be relieved from performance of its obligations of the terms of this Agreement caused by an event beyond the control of CIT Water Exchange including acts of Government and Water Authorities.
3. CIT Water Exchange will send a remittance advice via email or post relating to the sale of the water.
4. CIT Water Exchange will contact via text message if your Authority to Act to Sell Temporary Water expires after 30 days.
