## **GENERAL INFORMATION**

- **CIT Facilities** are all located on the River Murray or its anabranches in South Australia and are covered by the South Australian River Murray Water Allocation Plan.
- How are charges determined? Trust service charge cost base is largely fixed and relates to the size and nature of the infrastructure assets owned and maintained by Trusts. Consumption charges reflect the variable costs of water delivery and are significantly impacted by the cost of energy to operate pumping assets. A draft pricing schedule is approved annually by the Trust Board to ensure service standards are maintained at a minimum cost to customers. It is discussed with members at regional district meetings and then voted on at the AGM of the Trusts, where all members are invited to participate and vote on the schedule of charges. An approved Schedule of Charges is posted on the CIT website and sent to each member of the Trust.
- Landscape Water Levy The Levy is declared under Section 76 of the Landscape SA Act 2019 on advice from the Riverland and Murraylands Landscape Board and includes Water Management and Planning Charges. The levy is charged to your Trust in the first quarter of each year but the Trust collects the levy in 4 installments at each of the quarterly billing periods. - When are my charges due? Service Charges, Water Consumption Charges, Drainage Charges, and the Landscape Water Levy are billed to you quarterly in October, January, April, and July. Other Charges are billed as incurred. Payment beyond the due date will incur interest as regulated under Section 46 of the Irrigation Act 2009.
