Water Account Balancing

To improve water account management and address increasing risks, all water accounts must now be balanced **monthly**.

This change is driven by:

- A reduction in permanent water entitlements held within CIT.
- Greater reliance on the temporary water allocation market, which is subject to price and availability fluctuations.

CIT Support Measures:

- Guidance and reminders during the transition period.
- Flexibility to address unforeseen challenges.

Seasonal Water Quality Update

As the weather warms and irrigation demands increases, you may notice changes in water quality across our pipeline network. These seasonal shifts are normal and often influenced by river conditions.


For example, water from the Darling River—known for its higher clay content—can create ideal conditions for marine growth within pipelines.

Water Market Reform - What You Need to Know?



Ongoing reforms across the Murray–Darling Basin include:

- From 1 July 2024: All water trade applications must be fully completed and signed by all owners.
- Where price/reason for trade is required, records must be kept for 5 years.
- From 1 July 2026: New rules for data reporting to the Bureau of Meteorology will apply to market authorities and platforms.

These reforms may lead to changes in CIT's processes and documentation requirements. We appreciate your cooperation as we implement these updates.
